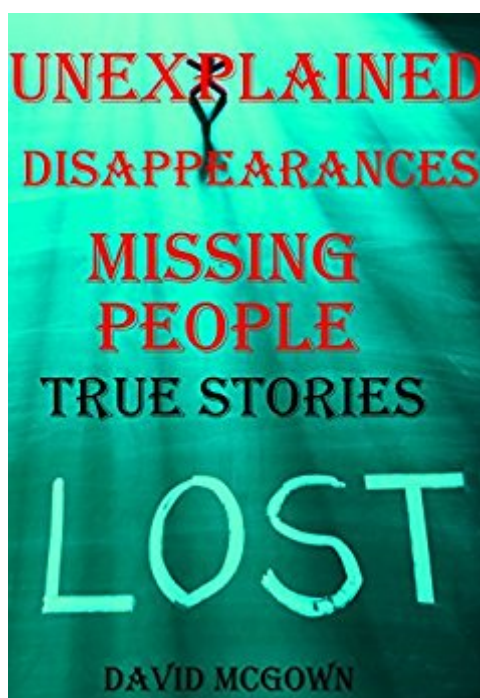

These are all cases I have seen on Discovery ID's show Disappeared and/or have done further research online intrigued by the mysteries surrounding these cases. In my opinion, there's a great deal of potential in this book that the author simply ignored. Perhaps the author should stick to fiction where he will do less damage to the victims and their families!! Reading Ebooks it is frequent to find misspelled words that I try to ignore. Apparently proofreading is truly a lost art! In this book there are so many errors that it negatively affects the very cases depicted. Getting the details wrong and mixing up who the author is even talking about while putting the information forward as fact is UNFORGIVABLE!!!
