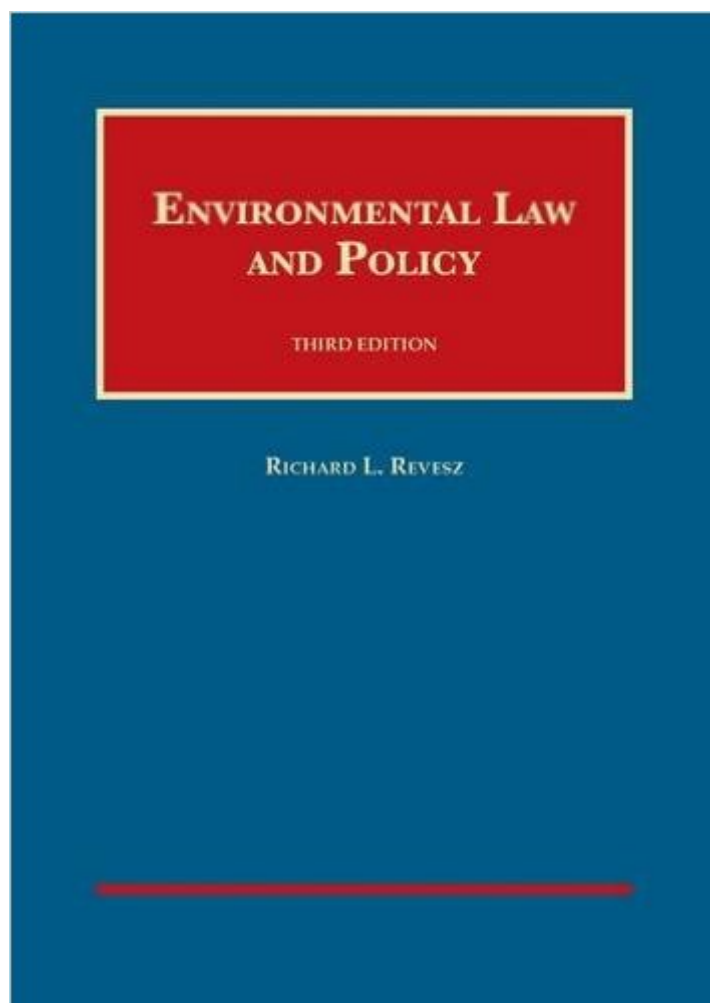

## Synopsis
